I. CALL TO ORDER/INTRODUCTIONS

Chair Hamilton called the meeting to order at 6:00 pm.

II. REPORTS FROM COMMMITTEES/REPRESENTATIVES

Friends of the Library Report – Fundraising Event

Buff Megaw reported on the Beer, Brats, and Books fundraising event held on October 19, at Central Library. Mark Jilg, owner of the Craftsman Brewing Company donated his beer and services for the evening. Robin Salazar, owner of Robin's Woodfire BBQ & Grill catered the event. The menu was BBQ'd bratwurst, sauerkraut, onions and garlic fries. Richard Hawthorne, owner of Central Grounds opened his coffee cart and served coffee throughout the evening. The Friends raised almost \$5,000. This will be an annual event. No action taken.

Branch Manager Jean Penn reported on the programs and events at Hill Avenue. She is also branch manager for the Allendale Branch as part of the branch pairing. No action taken.

III. COMMUNICATIONS

There were no articles.

IV. ACTION ITEM - APPROVAL OF MINUTES

Commissioner Dent moved, and Commissioner Bluestone seconded, to approve the minutes of October 16, 2013. The motion carried 6:0. Hamilton abstained, Ayala and Haderlein absent.

V. ACTION ITEM – APPROVAL OF MEETING CALENDAR

Chair Hamilton asked the commission to approve the meeting locations for 2014. Director Sanders noted that historically, the commission does not meet in August. However, with the school year starting earlier, she suggested canceling the July meeting instead. Chair Hamilton moved, and Commissioner Bluestone seconded, to approve the 2014 calendar as amended. The commission unanimously agreed.

Commissioner Gonzalez asked if there is another available date to meet at Villa Parke since the July 16 meeting at Villa Parke is cancelled. Director Sanders offered March 19. Commissioner Wang moved, and Commissioner Calkin seconded, to approve the amended 2014 calendar. The commission unanimously agreed.

VI. COMMUNITY COMMENT

There was no community comment.

VII. DIRECTOR'S REPORT

a. Integrated Library System (ILS) Selection Update

Director Sanders reported that of the 3 candidates who held demonstrations on October 29, 30, and 31, staff from both Glendale and Pasadena libraries unanimously chose Innovative Interfaces, Inc. They hope to have the City Council's approval by the end of the fiscal year. She added that Brigida Campos and Barbara Ayala were both instrumental in coordinating the RFP process. No action taken.

b. One City, One Story Update

Director Sanders reported that tomorrow (November 21) the Mayor will announce the book selection for the 2014 One City, One Story program. She invited the commissioners to attend. The event will be at Central Library in the Main Hall. No action taken.

c. California Library Association (CLA) Report

Commissioners Calkin, Gonzalez, and Siegel attended the CLA conference in Long Beach, CA and shared their experiences with the commission. Commissioner Siegel added that the information he received in the first session makes him think that Pasadena does things right. Commissioner Calkin commented that the legislative luncheon was good, but discouraging because there is no money for libraries and Governor Brown thinks that funding should be local. No action taken.

d. Legislative Update

Director Sanders reported that the senate bill supporting broadband for libraries is gaining traction, but currently there is no legislative action. No action taken.

VIII.NEW BUSINESS (COMMISSION INPUT)

Chair Hamilton reported that the San Rafael construction was completed on the patio and includes a high seating wall and sidewalk. The San Rafael Associates are planning a ribbon cutting in 2014.

Commissioner Siegel reported that La Pintoresca is in Vice Mayor Robinson's district. With the assistance of Field Representative Williams and Branch Manager Smith, they will start a branch association for La Pintoresca. As it is not a community to raise money, they plan to do outreach at churches and schools to increase visibility. Chair Hamilton offered to have the San Rafael Associates help them get started. No action taken.
