This office has received the application for the installation of an above ground cross connect cabinet at the subject location. Since this facility is not related to the U-Verse program (you may want to confirm) which is under an existing agreement with the City, the review, approval, and installation of said facility shall be processed in accordance with Title 12.22 of the Pasadena Municipal Code as telecommunication facility. Attached for your reference is PMC 12.22.

In accordance with the list for an application on PMC 12.22.050, the following numbered items are required for a non-wireless facility application. The attached submittals appear to satisfy item numbers 1 through 4. Item numbers 5 through 7 will be covered if and when a PW permit is issued. Please submit a processing deposit of \$3,400 (subject to partial refund or additional billing). In addition, notification is required to forward to both occupants and owners within 300 feet of the installation site, and any registered neighborhood associations. Attached for your reference is the packet with requirements. Please submit the notification packet along with the fee. There are profession mapping services companies that perform this service, let me know if you need any contact information.
