**1. Devil's Gate Reservoir Sediment Removal Project:**

On Monday, October 3<sup>rd</sup>, representatives from the Los Angeles County Department of Public Works will present an update on the Devil's Gate Reservoir Sediment Removal Project at the City Council meeting. Additionally I have attached a Save the Dave notice for the two scoping meetings that will be held to further define and receive public input on the flood control project. The first meeting will take place on October 5<sup>th</sup> at 6:30pm at the Rose Bowl and on the next one on October 12<sup>th</sup> at 9:00am at La Canada High School.

**2. Upcoming Public Safety Committee Meeting Items:**

On Monday, October 3<sup>rd</sup> the Public Safety Committee will meet on three important items impacting Pasadena. The items include a recommendation to adopt the Healthy Food and Beverage Vending and Procurement Policy; a presentation by the Police Department on California's Parole Reform and its impact in Pasadena; and a presentation on actions taken to minimize tailgating at the Rose Bowl.

Tentatively we are scheduling for the October 17<sup>th</sup> meeting of the Public Safety Committee an update regarding the status of Fire Stations 32 and 39. All Public Safety Committee meetings are open to the public and are held in the City Council Chambers starting at 4:15 pm. District 6 will also be hosting a Town Hall meeting on October 25<sup>th</sup> where the Fire Chief and City Manager will discuss Fire Station 39.

**3. Pasadena Public Library Conducting Online Survey:**

From September 28 to October 19, 2011, the Pasadena Public Library will be conducting an online survey ([pasadenapubliclibrary.net/impact](http://pasadenapubliclibrary.net/impact)) to find out how our customers use the library's computers and Internet connection and how this service has made a difference in their lives. This information will help the library improve its technology services and communicate the value of providing free access to computers and the Internet within the community. The IMPACT Survey is anonymous, available in English and Spanish, and takes 10 to 15 minutes to complete.

The survey is an extension of the U.S. IMPACT Study. Conducted in 2009, the U.S. IMPACT Study was the first large-scale investigation of the ways library customers use computers and the Internet at public libraries, why they use it, and how it affects their lives. The study was instrumental in providing evidence that access to the Internet at U.S. public libraries has a profound and measurable impact on individuals and communities. The study findings reported in first report, *Opportunity for All: How the American Public Benefits from Internet Access at U.S. Libraries* has helped public libraries throughout the United States improve public access services and advocate for better support of public access computing. The study's second report, *Opportunity for All: How Library Policies and Practices Impact Public Internet Access* was released in June of 2011.

The IMPACT Survey is coordinated by the University of Washington with generous support from the Bill & Melinda Gates Foundation. For more information about the IMPACT Survey, visit <http://impactsurvey.org>.
